Minimum of 3 consecutive months with Level 1 Learner's License.

To ensure your teen's placement in a class, complete an application either online or by mail, be sure to include the fee of \$35 for returning students or \$50 if student did not take Segment One with Century. Class size is limited by state requirement, thus it is first come, first served.

Segment II Teenage Course Provisions:

1. Century Driving Group LLC dba Century Driving School will provide 6 hours of classroom instruction.
2. Century Driving Group LLC dba Century Driving School will supply all materials for the class.
3. Upon graduation of the course, the student will be issued a "Michigan Driver Education Certificate of Completion" attesting to his/her completion of the requirements that the Michigan Department of Education has set for Segment II of the graduated licensing program.

Terms:

The parent or guardian authorizes the student to take part in the program on the basis that the student meets the physical requirements specified by the law for issuance of a motor vehicle operator's license. For a student to participate in Segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a Level 1 License, which has been held for not less than 3 continuous months. The student must also show proper verification (**permit and the log of 30 hours of driving**) on the first night of class. The parent/guardian agrees to pay the fee prior to or on the first class date of **\$35.00** if the student took Segment I through **Century Driving School** or **\$50.00** if Segment I was taken elsewhere. The student is only guaranteed a position in the class when a payment is received prior to the class date. There is a \$25.00 fee for all returned checks.

Along with driving, comes responsibility. We have found that behavior problems will affect the learning of other students in the classroom. Behavior problems will result in an automatic dismissal with no refund.

Refund Policy:

If for any reason you decide to withdraw or not take the course, there is no refund.
